Student Section – Privacy Policy

This Privacy Policy explains how Student Section LLC ("**Student Section,**" "we," "our," or "us") collects, uses, discloses, and safeguards your information when you use the Student Section mobile application and related services (collectively, the "**Services**").

1 Scope & Eligibility

Student Section is intended **solely** for individuals who:

- 1. Are at least 18 years old (or the age of majority where they live, if higher); and
- 2. Can authenticate with a valid @umich.edu Google account (we may later admit other universities).

We **do not perform automated age-verification**; by creating an account you represent and warrant that you satisfy these requirements.

2 Information We Collect

3 How We Use Information

We never sell or rent personal data.

We use your information to:

- 1. Facilitate ticket listings, escrow, sales, and electronic transfer;
- 2. Authenticate users and detect fraud (including bot activity);
- 3. Communicate with you via email, push notifications, and in-app messages;
- 4. Provide customer support and resolve disputes;
- 5. Improve, test, and secure the App through analytics and diagnostics;
- 6. Comply with applicable laws, court orders, and law-enforcement requests.

We use administrative and technical safeguards to protect your data, including TLS encryption in transit and employ AES 256 encryption where applicable.

8 Your Rights & Choices

- Request the restriction of processing in certain circumstances;
- Receive your data in a portable format (data portability);
- Object to processing based on legitimate interests;
